



### CHAIRMAN'S MESSAGE



#### Dear esteemed members,

Starting from January 1, 2024, the EPR regulation (Amended Environmental Protection Law 2020) has officially come into effect. This marks a significant milestone in environmental protection efforts in Vietnam, setting mandatory requirements on businesses for managing and recycling packaging waste in their activities.

In the context that guidance policies about EPR regulations are still under process of being amended, PRO Vietnam is acutely aware of its role and the challenges ahead. With the successes achieved through pilot projects in previous years, we are confident that PRO Vietnam is fully prepared to fulfill the EPR obligations on behalf of its members.

In 2023, PRO Vietnam excellently achieved the pilot collecting and recycling target of 13,000 tons of various types of packaging. This is a foundation for PRO Vietnam to achieve the goal of collecting and recycling estimated 70,000

tons of packaging registered by members from the beginning of 2024.

Moving into 2024, PRO Vietnam has closely worked with the National EPR Office to apply successful pilot models into implementation. Starting the first quarter with determination and responsibility, PRO Vietnam is proud to gain positive achievements.

- Finalized agreements with partners to get the collection-recycling system ready to fulfill members' EPR needs. Thanks to the proactive efforts, in Q1-2024, PRO Vietnam collected over 18,000 tons of various types of packaging, according to the set plan.
- Promoted communications through expanding cooperation with major media outlets such as VTV and Tuoi Tre Newspaper..., launched activities to raise awareness about waste segregation and recycling in the community, And advocate for EPR policies implementation.
- Coordinated with relevant stakeholders to make the collection process more accessible and supported recyclers to meet the target of 2024.

In addition, PRO Vietnam consistently supports the business community, to build our strengths and attract more businesses to join hands in pursuing our common mission of promoting the circular economy. In Q1- 2024, we welcomed 2 new members, bringing the total to 24 members.

### Unveiling the brand identity of PRO Vietnam Packaging Recycling Joint Stock Company

As an operational arm of the Packaging Recycling Organization Vietnam (the Coalition), PRO Vietnam Packaging Recycling Joint Stock Company (PRO JSC) assumes legal status and serves as the representative entity for the Coalition in executing memorandums of understanding, andagreements with various stakeholders and partners to ensure the seamless and optimal implementation of communication, collection, and recycling projects.

In the initial quarter of 2024, PRO JSC officially introduced its distinctive brand identity, derived from the Coalition's brand identity, featuring the color green of PRO Vietnam. The company's logo has been in active use since March 2024. Publications and communication materials developed in accordance with this brand identity are currently in the final stages of preparation and will be swiftly released for use.









### Acknowledging and elevating the role of informal workers



On the occasion of International Women's Day 2024. the United Nations Development Program (UNDP) Vietnam - Gender Equality and Social Inclusion Technical Group of the National Action Partnership Program on Plastics (NPAP), in collaboration with the International Union for Conservation of Nature (IUCN) through the IUCN-PRO Vietnam Strategic Partnership Program, convened a consultation meeting in Hoi An. The focus was on recognizing the contributions of informal workers (IWWs) in waste reduction, discussing proposals for the Global Agreement on plastic pollution, and integrating the informal sector into Extended Producer Responsibility (EPR) initiatives.

The workshop witnessed active participation from state agencies, research units, Gender Equality and Social Inclusion Group members, including representatives from various organizations such as the Institute of Strategy and Policy (ISPONRE), Canadian Embassy in Vietnam, DONRE, UNDP, IUCN, EPR Vietnam Office, PRO Vietnam, recyclers, and the media. It was highlighted that EPR policies will significantly impact waste collection, segregation, and recycling systems, in which the informal sector plays a substantial role. According to The Circulate Initiative (2023), globally, about 60% of plastic waste is collected and recycled by about 20 million informal workers, who are one of the most vulnerable and marginalized labor groups. In Vietnam, where 90% of the informal sector workers are women, helping to collect more than 30% of recyclable plastic waste to mitigate the burden of formal collectors and reduce public budget spending on waste management. To foster a circular plastic economy and implement national plans effectively, it's necessary to provide informal workers with opportunities to enhance their livelihoods and support their transition into formal waste management systems.



Prior to the meeting, delegates and the Technical Team visited experimental models like the 'Green House' and 'Happiness Store,' developed by the quiet heroes—the scrap collection groups—in Hoi An city. Understanding local circumstances and promoting innovative solutions will facilitate NPAP Gender Equality and Social Inclusion Group to deploy practical activities across Vietnam localities.

# **PRO** Vietnam has partnered with TGM Research to conduct a survey on waste segregation at source

In March 2024, PRO Vietnam entered a non-profit collaboration with TGM Research, a market research firm, to conduct a comprehensive survey on waste segregation practices in Vietnam. The survey, slated to span six months from the agreement's signing, will be fully funded by TGM.

This collaboration aims to provide PRO Vietnam with valuable insights into consumer behaviors in waste segregation and recycling in Vietnam. By understanding these behaviors, PRO Vietnam can tailor its recycling initiatives to better align with consumer needs and habits and can enhance the effectiveness of our communication programs.

Furthermore, this collaboration underscores PRO Vietnam's growing influence and positive reputation, attracting partnerships from businesses that share similar values and development orientation.

# Mondelez Kinh Do advances sustainable packaging through proactive EPR implementation



In a recent development, Mondelez Kinh Do Vietnam signed a strategic partnership with Dong Tien Paper Company Limited and Vinh Xuan Company Limited aimed at enhancing packaging collection and recycling capabilities. This collaborative effort highlights the proactive approach of Mondelez Kinh Do Vietnam and its partners in complying with EPR regulations and reaffirms Mondelez Kinh Do's dedication to sustainable development.

Under the 3-year strategic cooperation spanning from 2024 to 2026, Dong Tien Co., Ltd., functioning as a paper recycling facility, will undertake the collection and sorting of used paper packaging, which will then be processed into semi-finished rolled paper. Subsequently, Vinh Xuan Co., Ltd. will utilize this semi-finished recycled paper to manufacture various types of finished cartons and paper packaging, catering to the needs of Mondelez Kinh Do Vietnam.

As a long-standing member of PRO Vietnam, Mondelez Kinh Do has consistently demonstrated its commitment to EPR implementation and has undertaken comprehensive sustainable development initiatives across various aspects, encompassing raw materials, climate, community, employees, and consumers.

### COLLECTION AND RECYCLING UPDATE

In line with the Board of Directors' directives and in preparation for the implementation of EPR as mandated by members, PRO Vietnam has taken proactive actions to partner with our collector and recycler to start operations since the first quarter of 2024.

Although not all members had completed the EPR authorization registration by the first quarter of 2024, PRO Vietnam successfully collected over **18,000 tons** of packaging.

### PRO Vietnam hosts training session "Declaration and Registration Guides for EPR"



On 23 February 2024, PRO Vietnam successfully organized a training session "Guidance on EPR Declaration and Registration" for members in Ho Chi Minh City. The session united participants from the National EPR Office and members of the Coalition.

Spanning three hours, the training session includes two main parts:

- Introduction to the declaration and registration form as outlined in Appendix IX of Circular 02/2022 issued by the Ministry of Natural Resources and Environment (MONRE), along with instructions for declaration and registration via EPR portal.
- Q&A session addressing inquiries about declaring and registering EPR obligations.

The second part of the meeting featured a dynamic exchange of ideas and discussions. PRO Vietnam Social Enterprise provided practical insights on the responsibilities of authorized parties and outlined the support PRO Vietnam can offer to support members in the implementation of EPR.


### COMMUNICATIONS SUPPORT
